Evaluation Report: Upload one document that represents the overall evaluation. This may be a technical report, journal article, slide deck, or other material that conveys the evaluation's process and findings. Reports from stand-alone data collection events (such as a survey or focus group) are discouraged.

Evaluator's Statement (optional): The evaluator's statement is an opportunity for the evaluator or evaluation team who conducted the nominated evaluation to highlight aspects of the evaluation that they think are especially noteworthy. Note: This should be a statement especially prepared for this nomination, not an excerpt from an evaluation report.

Supplementary Materials (optional): You may submit up to two other materials that will help the judges assess the quality and utility of the nominated evaluation (e.g., blogs, articles from magazines, newsletters, or other media).
